

Rules and Regulations Governing Exhibits
57th Meeting of the American Academy of Maxillofacial Prosthetics

Exhibit Space: Booths for exhibits are available adjacent to the conference room at the Conference Site. Each booth is approximately 10' x 10' and includes a 6' long by 30" wide covered table and 2 chairs. You must provide a sign indicating your company name. No interference with light or space of any other exhibitor will be permitted. No signs or other articles may be posted, nailed or otherwise attached to hotel premises. Gasoline, kerosene, acetylene, or other flammable or explosive substances will not be permitted.

Contract: Exhibitor must execute a contract for the right to use the space allotted. Subletting space is prohibited. Exhibit space contracts will not be binding in the event of fire, strikes, riot, civil commotion, acts of God, war, or other unavoidable circumstances rendering the building housing the exhibits unfit for use, or that may prevent the presentation of the scientific session. Exhibitors shall indemnify and hold harmless the Westin San Diego, the American Academy of Maxillofacial Prosthetics and R.E.S. Inc. from all liability, which might ensue from any cause whatsoever.
